# 4 in 1 Combo protection plan may include:

## Tire & Wheel / Tire & Wheel with Cosmetic Repair Coverage

We will repair or replace your tire when it is damaged due to a road hazard and/or each wheel that will not seal or hold air after a tire is repaired or replaced due to a road hazard. Coverage includes the following as applicable: mounting, balancing, wheel weights, valve stems, patches/patch plugs and taxes required to complete a covered repair.

Cosmetic Repair Coverage pays to repair the appearance of your wheels when they are damaged due to a road hazard. Wheels will not be replaced or remanufactured if Cosmetic Damage is not repairable.



## Paintless Dent Repair

Paintless Dent Repair removes minor dents and dings up to 4 inches in diameter from painted steel or aluminum metal surfaces using a non-invasive process that does not compromise your vehicle's factory finish.

## Key Repair & Replacement

Repair or replacement of vehicle key(s)/remote(s) lost, stolen, damaged or destroyed, including any applicable programming. Coverage is limited to up to \$800 per covered repair or replacement and one key/remote replacement every 12 months.

We will reimburse you up to \$250 per covered repair or replacement to replace other key(s) lost, stolen, damaged or destroyed.

## Additional Benefits



### Towing and flat tire allowance

We will reimburse you up to \$100 per incident for towing assistance or flat tire replacement if your vehicle becomes inoperable due to damage to tire(s) and/or wheel(s) from a road hazard (regardless of whether it results in a covered repair). You must make your own arrangements for towing and flat tire replacement assistance.

Tire & Wheel and Tire & Wheel With Cosmetic Repair only.



### Substitute transportation

We will reimburse you up to \$50 per day, for a maximum of 2 days per occurrence, for expenses incurred to rent a substitute vehicle from a licensed rental car agency or for public or private commercial transportation. We will reimburse you for one day of substitute transportation expenses if it takes a repair facility 8 or more hours to complete a covered repair, and 2 days if the vehicle is kept overnight to complete a covered repair.

Tire & Wheel and Key Repair & Replacement only.  
Not available for Cosmetic Repair Coverage.



### Towing and lock-out allowance

We will reimburse you up to \$100 per occurrence for towing and/or lock-out expenses if your vehicle becomes inoperable or you are locked out of your vehicle, due to your vehicle key(s)/remote(s) being lost, stolen, damaged or destroyed, or locked inside of your vehicle (regardless of whether it results in a covered repair or replacement). This allowance includes reimbursement for expenses incurred to have your vehicle towed to a repair facility and/or to obtain assistance to unlock your vehicle. You must make your own arrangements for towing and lock-out assistance.

Key Repair & Replacement only.

## Limits and exclusions

Coverage is subject to limits and exclusions. Under some circumstances parts or services may not be covered. Please see the service contract for details. The replacement tire/wheel is limited to the same tire/wheel as the vehicle's original equipment manufacturer's tire/wheel or a comparable tire/wheel of like kind and quality if the original equipment manufacturer's tire/wheel is not available or out of production.
