### Pre-owned vehicle protection plan limits and exclusions

Under some circumstances, a breakdown of a covered part may not be covered (for example, failure due to misuse or lack of proper maintenance or when a non-covered part is what caused the covered part to fail). Also, the exclusions contain a list of parts not covered, some of which may be associated with a covered part (for example, spark plugs and wires; wheel balancing; tune-ups; glow plugs; any maintenance service or part required or recommended by the manufacturer). Please see the service contract for details. When replacing failed parts under this contract, we reserve the right to require the use of remanufactured, used or new parts of like kind and quality compatible with the original design specifications and wear tolerances of the vehicle.
