## Additional benefits

### • Towing allowance

If your vehicle is stolen and recovered within 30 days and is towed to a towing recovery lot. We will reimburse you up to \$50 per incident for towing assistance expenses incurred.

### • Substitute transportation

We will reimburse you up to \$35 per day, for a maximum of 20 days, for expenses incurred to rent a substitute vehicle from a licensed rental car agency or for public or private commercial transportation when your vehicle is stolen. You must make your own arrangements for substitute transportation.

### • Trip interruption

We will reimburse you for expenses incurred for meals and lodging up to \$100 per day for a maximum of 3 days or up to \$300 for one-way public or private commercial transportation back to your primary residence if your vehicle is stolen and the theft occurs more than 100 miles from your primary residence.

### • Homeowner's or renter's insurance deductible

We will reimburse you up to \$500 for your homeowner's or renter's insurance policy deductible if your personal property is stolen from your vehicle on the date of loss.

### • Primary automobile insurance carrier deductible

We will reimburse you up to \$500 for your primary automobile insurance carrier insurance policy deductible if your vehicle is stolen and recovered within 30 days and your vehicle incurs damage covered by the insurance policy issued by your primary automobile insurance carrier.

### Limits and exclusions

Coverage is subject to limits and exclusions. Under some circumstances, a theft may not be covered (for example, if the keys were left in the vehicle or the vehicle was left unlocked). Please see the contract for details.
