⌚ 24-hour roadside assistance

(Emergency Roadside Assistance must be obtained through contract dispatch)

Up to \$75 of coverage per incident for emergency roadside assistance is available for the following:

- Towing assistance
- Battery assistance (excluding hybrid batteries)
- Flat tire assistance (with vehicle's inflated spare)
- Fuel, water or other fluid delivery (excluding the cost of fluids)
- Lock-out assistance

🚘 Substitute transportation

We will reimburse you up to \$35 per day, for a maximum of 7 days per occurrence, for expenses incurred to rent a substitute vehicle from a licensed rental car agency or for public or private commercial transportation including but not limited to ridesharing services, while the vehicle is undergoing a covered repair or covered service.

You must make your own arrangements for substitute transportation.

📍 Trip interruption

We will reimburse you for expenses incurred for meals and lodging up to \$100 per day for a maximum of three days when the vehicle is undergoing a covered repair or covered service due to a mechanical breakdown that has occurred more than 100 miles from your residence and the repair facility keeps the vehicle overnight.

You must make your own arrangements for meals and lodging.

**Additional benefits may require out-of-pocket expense that is reimbursable under contract terms.

Total Term Protection limits and exclusions

Coverage is subject to limits and exclusions. The contract provides coverage for covered services in addition to coverage for repairs only of covered parts and only when they suffer a breakdown as defined in the contract. Under some circumstances, a breakdown of a covered part may not be covered (for example, failure due to misuse or lack of proper maintenance or when a non-covered part is what caused the covered part to fail). Also, the exclusions contain a list of parts not covered, some of which may be associated with a covered part (for example, spark plugs and wires; wheel balancing; tune-ups; glow plugs; any maintenance service or part required or recommended by the manufacturer). Please see the service contract for details. Replaced parts will, at our option, be remanufactured, used or new parts of like kind and quality compatible with the original design specifications and wear tolerances of the vehicle.
